The Discounts are available for rental purposes and the discount rates vary depending upon the amount of donations made to the temple. Above charges do include cleaning, cooking utensils, chaffing dishes, mandap etc.

THE Temple does not provide any set up arrangements or security. A signed contract with a FULL RENTAL CHARGE will be required WITHIN 5 DAYS OF THIS CONTRACT DATE. The Donor deposit will be applied to the rental charge. The rental and cleaning charges must be paid in full at least THIRTY days prior to the scheduled event. The RENTAL charges will be forfeited if the Donor cancels booking within 60 days prior to the event. Any type of adhesive tape for decoration purposes on temple walls is not permitted. All decorations must be removed before the end of rental day.

Temple does NOT ALLOW non-vegetarian items to be cooked or brought to its premises. Further, Virginia ABC Board requires each user to apply for a license a minimum of seven (7) working days (M-F, excluding holidays) prior to the scheduled event date. For private parties, ABC permit MUST be presented to the Temple Committee prior to any beer, wine or liquor being brought to the building. A copy of the permit must also be posted on the day

of the scheduled event. Please note that liquor can be served only in the dining hall.

If the event runs past 2 am, THERE WILL BE AN ADDITIONAL FEE OF \$100 PER EACH 30 MINUTES OR ANY PORTION THEREOF. (Remember 2:00 AM is the DEADLINE for the temple facilities to be closed)

For private functions, donor s should have their own insurance. Temple insurance will not afford protection to either you, your patrons, guests or organizations.
